Confirmation

Until payment is received in full, the registration will be held on "optional" status and cannot be confirmed. Pricing of ISBT 2020

Fees for the ISBT 2020 vary according to the registration categories. ISBT does not charge VAT on Registration fees.

Payment

Payment of the online registration fee is by credit card (secured online payment system accepting Visa, Amex and MasterCard). Bank transfer, cash or cheques cannot be accepted. All registration fees referred to are in Euro, and payment must be made in Euro. Full payment is due at the time of registration.

Invoice

Only digital versions of invoices will be sent to participants upon completion of the online registration. The invoice will be issued using the contact details provided on the registration form so please make sure you have provided us with the correct information.

Cancellation of Congress registration
