

## **Terms and Conditions Congress Registrations**

These Terms and Conditions apply to the registration and participation of a congress organized by ISBT. Please read these Terms and Conditions carefully before you register for the ISBT Congress. By registering for the ISBT Congress (as of sending the filled in online registration form), you confirm that you have read, accepted, and agree to be bound by these Terms and Conditions, including liabilities and the applicable law. If you do not agree to these Terms and Conditions, do not register for the ISBT Congress. By completing the registration on behalf of another individual, you are warranting that you have informed the participant that these Terms and Conditions apply to the registration and participation of the ISBT Congress, and you have shared a copy of these Terms and Conditions.

*ISBT reserves the right to unilaterally change these Terms and Conditions, at its sole discretion at any time and without prior notice, whenever it deems necessary.*

### **Registration for the ISBT Congress**

Registration for the ISBT Congress can be made via the website of ISBT: <http://www.isbtweb.org>. All registrations must be processed online via an online registration form. For this, please select the relevant ISBT Congress and click on the “Registration” button and follow the instructions step by step. Specific information may be requested during the registration process for individuals and group registrations directly or indirectly related to the code of conducts applicable to the organization of an ISBT Congress and pharmaceutical industry’s compliance regulations. Upon completion of your online registration, you will be sent an acknowledgement email. The email is sent to the email address provided on the registration form and will include an invoice.

### **Registration fees**

Registration fees for the ISBT Congress may vary depending on the date you register, as indicated by the registration categories and deadlines on the registration website. All registration fees referred to are in Euro (€), no other currency will be accepted. No VAT is charged on Registration fees.

### **Payment & confirmation**

All registration fees referred to are in Euro (€). All registration payments must be made in Euro. No other currency will be accepted. No cash or checks are accepted. Full payment is due for the registration fees. Registrations are only confirmed once the required payment has been received. You will receive a confirmation email from the ISBT Registration Department ([ISBTregistration@mci-group.com](mailto:ISBTregistration@mci-group.com)) upon receipt of the payment.

Only digital versions of invoices will be sent to participants upon completion of the registration. The invoice will be issued using the contact details, or additional address details, provided on the registration form.

### **Payment by credit card - VISA, Eurocard/MasterCard, American Express**

The online registration platform is a secured site. VISA, Eurocard/MasterCard and American Express are the only credit cards accepted via the registration system. Please enter all relevant information on the payment page of the online registration system. Upon completion of the online registration and payment process, you will receive a paid invoice by email. Payment by credit card is recommended as then your registration is immediately confirmed.

### **Name changes**

For name changes an administrative fee of €45 will be charged. For each name change you must notify the Congress registration office **by e-mail to [ISBTregistration@mci-group.com](mailto:ISBTregistration@mci-group.com) before May 5, 2026**. Name change participants agree to take over all booked program items of the originally registered participant.

### **Cancellation policy**

In case you wish to fully cancel your congress registration, the Registration Department must be notified **in writing by sending an e-mail to [ISBTregistration@mci-group.com](mailto:ISBTregistration@mci-group.com)**.

The following cancellation conditions apply:

- In case the cancellation is received **before or on April 15, 2026**, the registration fee will be refunded with a deduction of 50%, as administration charge.
- In case the cancellation is received **after April 15, 2026**, the registration fee will not be refunded for cancellations or no-shows.

Any refunds due will be processed within 30 days after the congress dates.

### **Cancellation policy for congress party ticket**

If you wish to cancel your congress party ticket, the same conditions mentioned above apply. This means that tickets cancelled before or on April 15, 2026 will be refunded with a 50% deduction as an administration charge, and tickets cancelled after this date will not be refunded.

During onsite, if we have a waiting list for the congress party, you will be able to cancel your ticket with only a 50% charge. This onsite option is only available if there are delegates on the waiting list and if the cancellation is processed directly at the registration desk during the congress.

### **Invitation letter for visa application**

All delegates requiring a letter of invitation for visa application purposes may request this letter during the online registration. We will not be able to issue any letter of invitation without receiving the registration and the payment of the required registration fees. Please note that the organizers will not be able to contact or intervene with any Embassy or Consulate office on behalf of a delegate.



The ISBT cannot be held responsible if your Visa is not approved and registration fees cannot be remitted.

### **Photographs and (audio) recording**

ISBT reserves the right to photograph and videotape the Congress and participants and to use such photographs and videos in any internal and external communication referring to the Congress or ISBT, such as on its websites and intranet, or other publications. By registering you consent to such uses.

### **Data protection**

By registering to this event, you agree that your personal data will be processed by ISBT and the Congress registration office, for registration and handling purposes, and to send you information in connection to ISBT events. If you do not submit the data indicated as 'required', we cannot complete your registration.
